Dear **Senior** High School Soccer Player & Parents:

Hi, my name is Gregory A. Juba and I am representing the Minnesota State High School Soccer Coaches Association (**MSHSSCA**). I am also the Head Girls' Soccer Coach at Park (Cottage Grove) High School. The **MSHSSCA** is going to be running its 20<sup>th</sup> Annual Soccer Coaches Clinic on Friday, August 13, 2010. The clinic is going to be at Hopkins High School.

It would be suitable if you were in soccer attire with your high school name on it. Please mail the **signed waiver** to **Coach Crissy Makela**, **ASAP**. She will be in charge of taking care of you during the entire day at Hopkins High School. It will be a fun, exciting and super day for you.
